Enclosed for filing pursuant to Section 3 of the Natural Gas Act ("NGA"), 15 U.S.C. § 717(b)(a)(2004), and Parts 153 and 380 of the Commission's Regulations, 18 C.F.R. Parts 153 and 380 (2004), is an "Application for Authorization to Site, Construct and Operate Liquefied Natural Gas Import Facilities" ("Application") submitted by Calhoun LNG, L.P. ("CLNG") and Point Comfort Pipeline Company ("PCPLC") (together "the Applicants").

CLNG is seeking authorization to site, construct and operate a liquefied natural gas ("LNG") receiving terminal and associated facilities to be located at the Port of Port Lavaca – Point Comfort as a place of entry for the importation of LNG.
